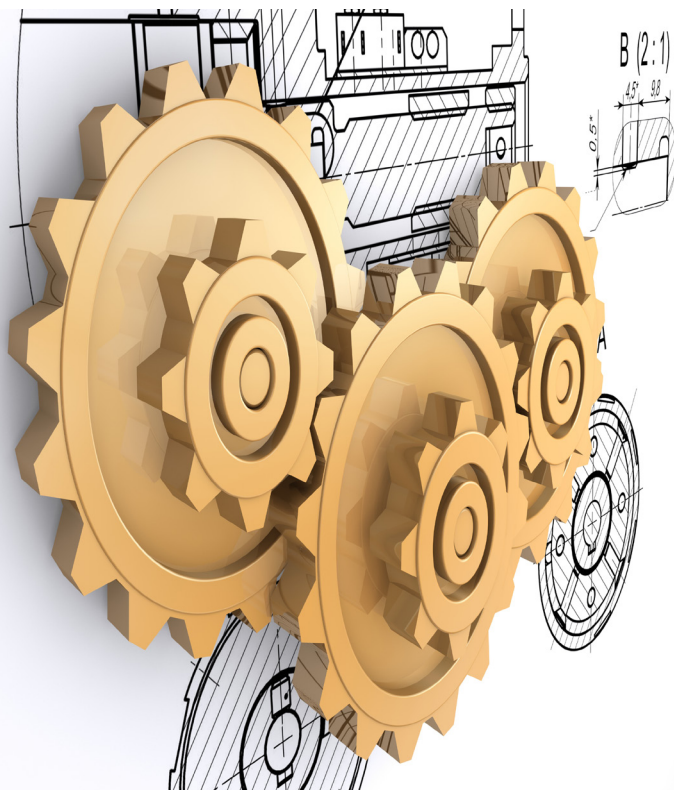

Picking tickets and receipts may be printed in either a 40 or 80 column format.
